1. What does cookie mean?

A cookie is a small text or alphanumeric file that websites record on their visitors' computers or mobile devices. Cookies are widely used to improve the functioning of websites, provide a personalised online experience or otherwise enhance the user experience, or to provide website owners with various information. Cookies alone do not identify the user, they only recognise the visitor's computer.

We may place cookies on visitors' computers without their consent if they are strictly necessary for the website to function properly. For all other types of cookies, we need your consent.

During your visit to our website, we collect your personal data through cookies, server logs and other technologies, including in particular your IP address, user agent data, browser type, time of your visit and possible preferences.

The cookie is valid and active within the expiry date set when you place it. So-called “session” cookies are valid and active only as long as you keep the website open on your device, and are no longer valid immediately after you close the website. The validity period of permanent cookies is defined in months, days or years. Once the permanent cookie expires, your browser will automatically delete the cookie when you visit the site again. You can also delete permanent cookies from your browser within the validity period.

The website also contains third-party cookies, which can only be placed on the visitor's computer with their consent.

As stated above, the cookies used on our website below, which are necessary for its operation, are placed on the computer of the visitor each time he or she visits the website and the visitor's consent is not required:

ga#	Google Analytics cookie used for statistical purposes. Used by the Google tag manager for measurement.	Permanent	2 years
_ga	Google Analytics cookie used for statistical purposes. Identifies the user for the Google tag manager.	Permanent	2 years

LAST_RESULT_ENTRY_KEY	Youtube uses it to track user interactions with embedded content.	Session	End of session

remote_sid	Necessary for the operation of Youtube.	Session	End of session
requests	Youtube uses it to track user interactions with embedded content.	Session	End of session
YSC	Youtube uses it to identify the user.	Session	End of session

2. How do we use cookies?

We may use any personal information we obtain from the cookies we place for the following purposes:

- For technical reasons (e.g., but not limited to identifying sessions, remembering settings or preferences, etc.);
- To create statistical analyses and for web traffic management purposes (e.g. to improve the usability of your website and the relevance of your services, to analyse information about the use of your website by visitors based on the pages visited, number of accesses, location, etc.);
- To better target our marketing materials and optimise our ads for visitors.

3. How can you prevent your computer from receiving cookies?

You have the right to object to the processing of your personal data through cookies, in particular by withdrawing your consent to the use of cookies for statistical purposes directly in the cookie pop-up window on your first visit to the website.

You also have the option to configure your browser to generally disable the installation of cookies. Any recent web browser allows you to change your cookie settings. These settings are usually found in the “Tools”, “Options”, “Help” or “Settings” sections within your browser, which you can explore by following the links below, depending on which browser you are using.
