Data subjects' rights, remedies

You, as data subject, may at any time request information about the processing of your personal data and access to these data, as well as request the rectification, erasure or withdrawal of your personal data, except for mandatory processing, and exercise your right to data portability, by contacting us at the above contact details. You may object to processing based on legitimate interest at any time.

Upon your request, we will provide you with the requested information without delay, but within one month at the latest, free of charge, unless the request is unfounded or excessive.

Right to information:

Where we process your personal data, we are obliged to provide you with information in accordance with the GDPR, in a clear and understandable form, but at the same time accurately.

The right of access of the data subject:

You have the right to receive feedback from us on whether your personal data is being processed if you request it. If your identity is properly verified and your personal data are being processed, you have the right to be informed of the details of the processing and to receive a copy of your personal data.

Right to rectification:

Any data subject, including you, may request the rectification of personal data that we hold about you which is inaccurate for any reason, or the completion of incomplete data.

Right to erasure:

You have the right to request the erasure of your personal data for one of the following reasons:

the personal data are no longer necessary for the purposes for which they were collected; if you have withdrawn your consent and there is no other legal basis for the processing;

if you object to the processing and we have no other overriding legitimate grounds for processing;

unlawful processing of personal data can be established; we have another legal obligation to erase the data.

Right to the restriction of processing:

You may request the restriction of the processing of your personal data in the cases set out in the GDPR. For example, to verify the disputed accuracy of personal data or if you request that data that would otherwise be deleted be kept in order to pursue a legal claim. If the processing is restricted, the personal data will only be stored and processed in exceptional cases. You will be informed in advance of the lifting of the restriction on processing.

Right to data portability:

You have the right to receive your personal data from us in a structured, commonly used, machine-readable format and to transfer this data to another data controller. We can fulfil such requests in MS Word or Excel format. You have the right to data portability if the processing is automated and the legal basis for the processing is your consent or the performance of a contract.

Right to objection:

If your personal data are processed for direct marketing purposes, you have the right to object at any time to this processing, including profiling, if it is also related to direct marketing.

If you object to the processing of your personal data for direct marketing purposes, we will not process your data following your objection.

You also have the right to object if the processing is based on legitimate interest for purposes other than direct marketing. In such cases, we will consider complying with the request, depending on whether your rights, or our rights as data controller, take precedence in accordance with Article 21 (1) GDPR.

Right to withdraw consent:

In cases where we process your data on the basis of your consent, you have the right to withdraw your consent at any time. Withdrawal of consent does not affect the lawfulness of the processing that took place before consent was withdrawn.

Procedural rules:

Upon your request it, we will inform you of the action we have taken on your request without undue delay, but in any event within one month of receiving it. If necessary, taking into account the complexity of the application and the number of requests, this deadline may be extended by a further two months. We will inform you of the extension, stating the reasons for the delay, within one month of receiving your request.

If you submit your request to us in any form, we will respond by e-mail unless you request otherwise.

If, for any reason, we do not take action on your request, we will inform you without delay and at the latest within one month of receipt of the request of the reasons for the failure to act, and that you may lodge a complaint with the supervisory authority and exercise your right to judicial remedy.

We will inform any recipient to whom or with whom we have disclosed your personal data of any rectification, erasure or restriction of processing we have carried out, unless this is impossible or involves a disproportionate effort. We will inform you of these recipients on request.

If you believe that your right to information self-determination has been violated, you have the right to lodge a complaint with the National Authority for Data Protection and Freedom of Information at the following contact details.
